District 13 Natural Resource Assistance Council (NRAC) announces the application period is now open for Round 11 of Clean Ohio Green Space Conservation Funding. Approximately \$4,745,567 is available to local communities and non-profit organizations to preserve natural areas, protect streams, and create outdoor recreational opportunities. Applications for Green Space improvements under the Clean Ohio Round 11 program will be accepted July 13, 2016, through January 26, 2017.

District 13 is comprised of Allen, Auglaize, Hancock, Logan, Mercer, Putnam, Shelby and Van Wert Counties.

Applications for Green Space Conservation funds may be requested through the Ohio Public Works Commission, 65 E. State St., Suite 312, Columbus, OH 43215, phone (614) 466-0880, can be downloaded off the internet at [www.pwc.state.oh.us](http://www.pwc.state.oh.us), or can be obtained through County NRAC Representatives (see below). Applications can be submitted to Chairman Howard Elstro, 50 Town Square, Lima, OH 45801-4900. District 13 NRAC requires twelve (12) copies of the application to be submitted.
